LABOUR FACTORIES BOILERS AND INSURANCE MEDICAL SERVICES DEPARTMENT (Lab-II)

EASE OF DOING BUSINESS(EODB) - STATE REFORMS ACTION PLAN-INTRODUCTION OF SELF COMPLIANCE CERTIFICATION/THIRD PARTY COMPLIANCE CERTIFICATION INSTEAD OF DEPARTMENTAL INSPECTIONS UNDER FACTORIES ACT, 1948 & ANDHRA PRADESH FACTORIES RULES.

[G.O.Ms.No.8, Labour Factories Boilers and Insurance Medical Services (Lab.II), 3rd December, 2020.]

NOTIFICATION

The Government of India, Department of Industrial Policy and Promotion, Ministry of Commerce and Industry, New Delhi have recommended the introduction of Self-Certification/Third Party Certification of compliance instead of departmental inspections for verification of compliance of provisions under the Factories Act, 1948 to improve Ease of Doing Business (EoDB) in the State of Andhra Pradesh. Accordingly, the State Government have decided to introduce a scheme of "Self Compliance Certification/Third Party Compliance Certification, 2020" instead of departmental inspections have decided to introduce in the State as follows:-

A. Self / Third Party Compliance Certification Scheme under Factories Act

- This scheme is extended to factories covered under Factories Act 1948 with effective from December 2020 and shall be in force till it is cancelled or modified.
- 2. The following factories are not eligible to apply under this scheme.
 - a. Factories not holding a valid license under Factories Act

- b. Factories in which an accident had occurred during last 3 previous calendar years resulted into fatality or serious bodily injury or any dangerous occurrence resulted into Fire, Explosion, Bursting, Release of Toxic Gases, Spillages of Hazardous and molten metals, Collapse of structures/ buildings.
- 3. This scheme is optional. Hence the occupiers of factories which have been allocated for departmental inspection have to exercise their option of either Self certification of compliance or Third-Party Certification of compliance or Departmental inspection within 15 days from the date of allocation for inspection in the online CIS portal.
- 4. Those who have opted for Self-certification shall download the checklist for compliance from CIS portal and upload the self-certification in the manner prescribed at least 30 days before the scheduled date of inspection failing which the departmental inspection shall be carried on as per the schedule in accordance with the procedure in force.
- 5. Those who have opted for empanelled third party certification shall engage a third party from the list of empanelled third parties on random allocation by CIS portal if available. In case of non-availability of this system in CIS portal, the occupier himself shall engage the third party from the list of empanelled third parties in accordance with the guidelines issued, if any, by the Director of Factories. The engaged third party shall prepare the certification with the checklist to be downloaded from CIS portal and upload the same in the manner prescribed at least 30 days before the scheduled date of inspection failing which the departmental inspection shall be carried on as per the schedule in accordance with the procedure in force.
- 6. There will be no regular departmental inspections for those factories which have opted for either Self Certification or Third-Party certification and admitted by the concerned department, till the next inspection is scheduled by CIS portal. However, this will not obstruct the inspections/visits based on accidents, Complaints, Special Drives launched by Director of Factories, Mock Drills, Training Programs, Interactive meetings and any other circumstances wherein the enrolment is not admitted into this scheme or the admission stands cancelled.
 - Further, any certification uploaded within the stipulated time and no objections are communicated for a period of 14 days from the date of uploading shall be deemed to have been admitted.
- 7. The factories of the occupiers who have opted for the departmental inspection will be inspected on random allotment as per the existing procedure through CIS portal based on the checklist in CIS portal.
- 8. The frequency of inspections of factories shall be based on the risk potential of the factory which is classified as stipulated below. The criteria for classification are made available in CIS portal.
 - a. All the_High-Risk factories shall be once in a year
 - b. All Medium Risk factories shall be once in two years
 - c. All the low risk factories shall be once in three years
- 9. Procedure for Application into Scheme: The factories which have opted for self-certification or empanelled third party certification shall apply online for enrolment into the scheme in the prescribed format for enrolment (Annexure-I) through CIS portal by remitting an interest free 'Compliance Guarantee Deposit' (CGD) as prescribed in the table below.

- (i) The valid enrolment into the scheme is liable for cancellation under the following circumstances.
 - a. Whenever there is an accident resulting into fatality or serious bodily injury or dangerous occurrences as detailed vide 2(b) above due to violation of provisions of Factories Act & Rules besides Guide lines, norms, standards notified if any.
 - b. Whenever there is no valid license in force issued under Factories Act.
 - c. Whenever there is a complaint for non-compliance which is proved on enquiry.

The cancellation of enrolment under the above circumstances shall render the self- certification or Third-Party certification, as the case may be, cancelled and the CGD made at the time of enrolment shall be forfeited.

- (ii) The occupier can opt for cancellation of enrolment sui motto at any time during its valid period and under such a situation the CGD amount shall be deducted on pro rata basis for the period of certification availed and the balance (without interest) shall be adjusted towards the license fee to be paid under Factories Act for the subsequent calender years. Similarly, the CGD can be brought forward to the subsequent allotment of inspections in this scheme but under no circumstances it shall be refunded.
- (iii) The enrolment of any factory into the scheme does not relieve the occupier or manager or both from the responsibility under the law for the violations under Act & Rules if found at any time. The penalties prescribed under the Factories Act for the violations are in addition to forfeiting the CGD. The scheme is intended to regulate the compliance inspections under the Act & Rules.
- 11. Empanelment of Third Parties for Compliance Certification:
 - a. The third parties shall be individuals or the firms.
 - b. In order to facilitate the factory managements by keeping the persons/firms having relevant qualifications and experience readily available as third parties, the empanelment is proposed by grouping the factories based on the nature and risk potential as detailed in annexure-II. The individuals/firms qualified for high risk factories shall be deemed eligible for relatively low risk factories as stated in column no:6 of annexure-II. by mere submission of application along the proof of remittance of necessary fee stipulated therein.
 - c. In case of individuals, the minimum required qualifications and experience for empanelment are also detailed in annexure-II.
 - d. In case of firms, it shall have not less than 2 individuals associated with the firm applying for empanelment, who are qualified to be empanelled as third parties as per the criteria in annexure-II. The individuals associated in the empanelled firm are not eligible for empanelment in the individual category as long as the empanelment of the firm is valid.

- e. The individuals owning firms as proprietor with no other individual associated shall also be treated as individual under this scheme and the empanelment shall be given accordingly.
- f. The application for empanelment for individuals as well as firms shall be as per the proforma Form-TPI (Annexure-III) and Form-TPF (Annexure-IV) respectively. The applications shall be made to Director of Factories along with the proof of payment of the requisite fee.
- g. i. The applications for empanelment received in full shape shall be placed before the Empanelment Scrutiny Committee (ESC) which shall be constituted by Director of Factories under his chairmanship, with individuals having considerable experience in Operation/Maintenance of relevant Industries having good reputation, Safety Professionals or other individuals with relevant professional expertise as members.
 - ii. The individuals who are not empanelled third parties shall only be considered as members of ESC and the individuals who have served as members of ESC shall not be eligible for application for the empanelment as third parties in the scheme for the next two calendar years after ceases to be the member of the ESC.
 - iii. The Joint Chief Inspector of Factories dealing with this subject shall be the member convener for this committee and organize its meetings.
 - iv. There can, if necessary, be more than one ESC for this purpose by considering the grouping of manufacturing activities in Annexure-II.
- h. The ESC shall meet once in a quarter or as frequently as otherwise decided by the chairman of the committee and scrutinize the applications received, conduct the personal interviews either physical or virtual with the candidates applied for empanelment based on which the ESC may either recommend for empanelment or rejection. If the application is made by the firm associated with two or more individuals, all the individuals cited in the said application shall attend the personal interview either physical or virtual and accordingly the application of firm shall be recommended for empanelment if there are at least two individuals found meeting the qualifying criteria. The applicants recommended for empanelment by the ESC shall be issued with a certificate of empanelment. The certificate shall be issued for one year from the date of issue of the certificate.
- i. The individuals or the firms shortlisted for empanelment by ESC shall require to pay an interest free refundable cautionary deposit (RCD) equal to the annual fee payable for the groups applied for empanelment, within 7 days of acceptance of empanelment by ESC. The total RCD shall be forfeited if the person or firm empanelled as third party is found violated any condition in the certificate of empanelment or has acted in a manner inconsistence with the intent or the purpose of the Act and Rules made there under or has omitted to act as required under the act or the rules made there under or for any other reasons or observations in the certification is found false.
- j. The RCD is adjustable to subsequent years of empanelment if applied for renewal for subsequent years as prescribed.
- k. The individuals or the persons associated with the firms applied for empanelment as third Parties for certification shall not be above the age of 65 years and to be certified physically fit by a registered medical practitioner annually after attaining the age of 60 years by last birthday

onwards for carrying physical work of compliance assessment for the purpose of certification.

- The individual should not currently be a part time/full time employee in any factory listed in the State of Andhra Pradesh or its subsidiaries or branches elsewhere in the country.
- m. The individuals or the persons associated with the firm who are found to be with objectionable character are not eligible for empanelment as third parties.
- n. The certificate of empanelment shall stand cancelled in case of firms, if the persons empanelled leave the firm consequent of which or due to any other developments, the firm fall short of minimum two individuals at any given time in a year.

12. Renewal of Empanelment:

- a. Every individual/firm seeking renewal of empanelment as Third Party for certification of compliance shall submit an application in the prescribed format along with relevant documentary proof, payment fee, log record of work done in the previous empanelment year, Fitness certificate (If required) etc. at least 2 months before the expiry of the validity of the empanelment certificate to the Director of Factories, Andhra Pradesh, Vijayawada.
- b. The ESC shall evaluate the performance of the Third party with regard to quality of the work done during the previous year while considering the renewal. The committee shall also take into cognizance if there are any allegations of act of bribery or disclosure of information if any about the manufacturing or commercial or working processes which may come to their knowledge in the course of their work or any other relevant issues while examining the application of renewal of an individual or individuals in a firm and recommend for renewal of empanelment if found acceptable.

13. Functions of Empanelled Third Party:

- a. The third party engaged by an occupier of a factory shall abide by the terms and conditions of empanelment at all times.
- b. The third party shall record the compliance accurately without any concessions as per the checklist adequately supported with details and enclosures in order to establish the status of compliance.
- c. The third party is not entitled to depute any person on his behalf for carrying out the entrusted work. However, he may bring the assistance if required with permission of the occupier hiring the services of the third party whose particulars shall also be recorded in the certification.
- d. The certification duly signed by the third party as well as the occupier of the factory shall only be uploaded into the CIS portal within the stipulated time.

14. Penal action:

If an individual or firm empanelled as third party for compliance certification has been found violated any condition stipulated in the certificate of Empanelment or any other terms and conditions stipulated or has carried out the work or has acted in a manner inconsistent with the intent or the purpose of the Act or the Rules or guide lines or standards under which the certification of compliance is to be given or has omitted to act as required under the Act or

the Rules or guide lines under which the certification of compliance is to be given or any other reasons to be recorded in writing, the Director of Factories may, after giving the opportunity of being heard to the empanelled third party, revoke the certificate of empanelment. And in all such cases the cautionary deposit shall be forfeited and the individual/firm involved shall be black listed and shall not be eligible for applying again.
